Structural Lifetime Warranty

Artistry[®] warrants its pre-finished wooden wall against any manufacturing defects caused by improper milling, assembly, grading, and finish coating. This warranty applies only to the original purchaser and installation site, and is not transferable.

Structural lifetime Warranty means that our wooden wall products will remain free from delimitation (separation between piles) buckling, warping, twisting, cupping or crowning in normal environmental conditions.

Normal environmental conditions mean that heating and ventilation systems shall be designed to maintain a consistent room temperature of 75°F (24°C) and interior relative humidity level between 40% and 60% RH all year round. To ensure the best performance of your wooden wall.

Whenever this warranty is applicable, our liability shall be limited to replacing, or repairing the defective wall board(s) due to manufacturing defects in excess of 5% accepted industry norm, material only. Damage due to transportation, storage, installation, extreme indoor conditions (heat, dryness, or moisture) extreme sunlight exposure, or any other causes are not covered.

Exposure to excessive heat, dryness, or moisture may cause damage to your wooden wall. It is natural that some minor contractions and expansions may occur due to the wood's inherent properties. These occurrences will self correct with seasonal climate change and/or when suggested normal environmental conditions are maintained. Over time, natural color change may also occur on your wooden wall, which is not considered as defect.

To Obtain Warranty Service

The end user shall contact the authorized retailer where they purchased flooring within 30 days after defect is discovered. Original proof of purchase and original documents must be retained and should be presented upon request.
